## TURF AND PERIMETER APPLICATIONS

**Perimeter Application:** Apply 3.33 to 6.66 pounds per 1,000 sq. ft. to turf areas 6 to 10 feet wide around and adjacent to the structure.

**Turf Application:** Apply LESCO CrossCheck 0.069% Plus Fertilizer with suitable broadcast application equipment to ensure uniform coverage over the treatment area. Apply 3.33 to 6.66 pounds per 1,000 sq. ft. to control the following insect pests:
